Agility Trial: Contact Robin Confer and Chuck Young to lend your hand at the trials. They will be held on July 15, 16, and 17, the weekend before the shows.

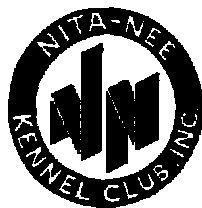

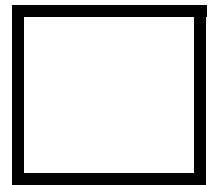
