Want to get some extra practice with exterior searches? This mock trial is all about exteriors!

Handlers and their dogs will explore the beautiful grounds of Camp Anderson alongside their own judge—an experienced club member who will time and score each team along the route. The course winds along shady, level gravel paths, crossing charming little bridges that cross the camp's streams. Surrounded by towering trees and rustic camp scenery, Camp Anderson offers plenty of shade and a relaxed atmosphere, making it the perfect place to spend a day with your dog.

Each team will complete four searches and may choose between the Novice/Advanced or Excellent/Masters levels. All searches will feature hides appropriate for the selected level.

For even more fun, teams are welcome to participate in two bonus searches that are suitable for all experience levels! Bonus search options include an interior, container, or exterior search, giving you and your dog even more opportunities to enjoy the day together.


Before starting a bonus search, we recommend taking a 30-minute break on the front porch while your dog relaxes in their crate in the car with water. This downtime helps both you and your canine partner recharge after completing the previous four searches and ensures they're ready to have a great time in the bonus rounds!

For each qualifying score, teams will receive a raffle ticket to win fun prizes including a free search at a future NNKC trial. An extra ticket can be earned by wearing a team themed jersey whether it be your football team, or a breed shirt showing your sniffing team spirit.

Come enjoy a relaxing day outdoors while building your skills and having fun with your canine partner!

The first search will kick off around 9:30 AM! Once we know how many teams are participating at each level, we'll email you your assigned timeslot. Timeslots are filled on a first-come, first-served basis, so the sooner you register, the better your chances of securing your preferred spot.

When you receive your confirmation email, your place is officially reserved. If your plans change and you're unable to attend, please let us know as soon as possible. If we're unable to fill your spot from the waitlist, you'll still be responsible for the registration fee. In the event of heavy rain or a thunderstorm, searches will be delayed until it is deemed safe to continue. If unable to continue, those not able to search will receive a refund. If your bitch goes into season, we will reschedule you to search at the end of the trial.

AGREEMENT

I understand that participation in the Sniff Around Event (the "Event"), whether as a participant, volunteer, or spectator, involves inherent risks. I acknowledge that I am voluntarily participating in or attending the Event with Full knowledge of these risks and assume all responsibility for any injury, loss or damage that I or my dog may sustain arising out of or related to the Event.

In consideration for being permitted to participate in or attend the Event, I hereby waive, release, and discharge Camp Anderson, Nita-Nee Kennel Club, and their respective owners, officers, directors, volunteers, representatives and affiliates (collectively, the "released Parties") from any and all claims, demands, causes of action damages, losses, or liabilities of any kind (collectively, "Claims") arising out of or related to my participating in or attendance at the Event, except to the extent such Claims result from the gross negligence or willful misconduct of a Released Party.

I further agree to defend indemnify, and hold harmless the Released Parties from and against any and all Claims, damages, costs, liabilities, and expenses (including reasonable attorneys' fees) arising out of our related to:

1. My acts or omissions;
2. The acts or omissions of my dog(s);
3. The acts or omissions of any minor, guest, or other person for whom I am responsible; or
4. My failure to follow Event rules, policies or instructions.

I represent and warrant that my dog(s) is/are current on their rabies vaccinations, and is physically fit to participate. I agree to maintain control of m dog(s) at all times and to comply with all Event rules and instructions.

I understand that the Released Parties reserve the right to remove any participant, spectator, or dog whose behavior is deemed unsafe or inappropriate, without refund.

I acknowledge that I have carefully read this Waiver of Liability, Assumption of Ris, and Indemnification Agreement, fully understand its terms, and understand that I am giving up substantial legal rights by signing it. I sign this agreement voluntarily and without inducement
